**PRE-CHARGE CONSENT ORDER**

**Background**

Robin Derwin was included in a Continuing Education Audit conducted by the Maryland Board of Social Work Examiners (“the Board”) on licenses requiring renewal by October 31, 2012. As a condition of continued licensure, licensed social workers are required to obtain forty (40) credit hours of Continuing Education Units (“CEU”) every two years in programs and categories approved by the Board, in accordance with Md. Code Ann., Health Occ. § 19-309(d)(3)(ii) and COMAR 10.42.06.03. The CEUs may all be in Category I but may not consist of more than twenty CEUs in Category II. A minimum of three CEUs, of the required forty CEUs, shall focus on ethics and professional conduct, including boundary issues. See *id.*

The audit revealed that Ms. Derwin has not completed the required continuing education, as she still needs to complete 5.5 Category I CEUs and 0.5 Category II CEUs.

In lieu of instituting formal proceedings against Ms. Derwin for violations of the Maryland Social Workers Act, Md. Code Ann., Health Occ. § 19-101 *et seq.*, the Board voted to resolve this matter by way of a Pre-Charge Consent Order. As a result, the Board and Ms. Derwin have agreed to resolve this matter as set forth in this Consent Order.

### **FINDINGS OF FACT**

1. At all times relevant hereto, Ms. Derwin was licensed to practice clinical social work in Maryland, License No. 02869. Ms. Derwin was first licensed by the Board on February 25, 1980, and her license is set to expire on October 31, 2014.
2. All licensees are required to sign a statement on the renewal application attesting to having completed this requirement. See *id.*
3. On April 1, 2013, Ms. Derwin was mailed a letter from the Association of Social Work Board (“ASWB”) on behalf of the Board stating that she was randomly chosen as part of a continuing education audit. This letter requested that Respondent supply continuing education documentation within thirty days of the letter.
4. A Final Notice was sent to Ms. Derwin on April 15, 2013.
5. A review of Ms. Derwin’s CEU certificates revealed that an additional 5.5 Category I CEUs and 0.5 Category II CEUs were not provided, and consequently, she has not met the required amount of CEUs.

### **CONCLUSION OF LAW**

Based on the foregoing Findings of Fact, the Board concludes that Ms. Derwin is subject to disciplinary action in accordance with Md. Code Ann., Health Occ. § 19-311 (4), (5), (6), (7), (13), and COMAR 10.42.06.03.

**ORDER**

Based on an affirmative vote of a majority of the Board, it is this \_\_\_ 12th \_\_\_ day of \_\_\_ July \_\_\_, 2013, hereby:


**ORDERED** that Ms. Derwin's license shall be REPRIMANDED; and be it further,

**ORDERED** that Ms. Derwin shall pay a fine in the amount of \$1,000.00, payable to the Maryland Board of Social Work Examiners, within ninety (90) days of the date of the Order; and be it further,

**ORDERED** that failure to pay in full the above fine within ninety (90) days of the date of this Order shall be considered a violation of this Order, and after notice and opportunity for a show cause hearing shall subject Ms. Derwin to further discipline such as suspension, revocation, or further fines based on the violations cited in this Order; and be it further,

**ORDERED** that this is a formal order of the Maryland Board of Social Work Examiners and as such is a public document pursuant to the Maryland Annotated Code, State Government Article, Section 10-617(h).

CONSENT


