FINAL ORDER

BACKGROUND

By letter received January 4, 1991, Christina Memphis, P.D., ("Respondent"), informed the Maryland Board of Pharmacy that she intended to surrender her license to practice pharmacy in the State of Maryland. The Board subsequently informed Respondent by letter of February 21, 1991 that the Board agreed to accept the surrender based on certain conditions that would be attached to that surrender. By signing and returning that letter on [date] (see attached Exhibit A which is incorporated into this Order), Dr. Memphis indicated her acceptance of those conditions.


ORDER

Based upon the Respondent's agreement in Exhibit A, it is this 20th day of March, 1991, by a unanimous vote of a quorum of the Board;

ORDERED that the surrender of Respondent's license has the same effect as would a revocation; and be it further

ORDERED that in the event that Respondent applies for reinstatement of her license to practice pharmacy, the Board may,

in its discretion, deny that request for reinstatement or attach any conditions it deems appropriate to that reinstatement.

Re: Your letter surrendering your license

Dear Ms. Memphis:

On January 4, 1991, the Board received your undated letter in which you state that you are surrendering your license. Under the Annotated Code of Maryland, 12-310.1, the Board may set conditions on the surrender of a license before accepting that surrender. With respect to your license, the Board will accept the surrender only if that surrender has the same effect as would the revocation of the license. In other words, if you should apply for reinstatement of your license at some future date, the Board could, in its discretion, deny that reinstatement or attach any conditions it deems appropriate to that reinstatement. Any application for reinstatement would not be covered by 12-309. Furthermore, the surrender of your license will only be accepted based on your acknowledgement that the Board's investigation of your license produced evidence that would have resulted in discipline against your license under 12-311 had the case proceeded to hearing and which evidence demonstrates a lack of good moral character on your part.

If you accept these conditions on the surrender of your license, you should sign this letter and return it to me prior to March 20, 1991. If I do not hear from you prior to that date, your surrender of your license will not be accepted by the Board, a hearing on the charges against you will be held on April 17, 1991 at 1 p.m. in Room 110 of 4201 Patterson Avenue, Baltimore, Maryland 21215 whether or not you are present (as provided by Health Occupations Article 12-315(g)), and the December 21, 1990 summary suspension of your license will remain in effect until another Order is issued by the Board.
