All persons who are known by the Issuing Office to have received the above-referenced IFB are hereby advised of the following revisions:

Specification Revision - Scope of Work Requirement Section 3:

CLARIFICATION STATEMENTS

1. The Contractor shall provide a unit dose module for tablets/capsules.
2. WMHC will use a Pyxis/or like system for all interim medications. The Center is not changing to a remote automated medication system. The machines will be utilized for first dose prior to medications being delivered by the Pharmacy.

SUBSECTION 3.2.4 – (Provide the following pharmaceutical services):

Subsection 3.2.4 item h – shall now read:

For patients/residents with Medicaid and Medicare Part D, the Contractor shall bill these agencies and accept the amount paid by these agencies as payment in full. The Pharmacy will be the facility for Medicare Part A days and will bill the insurance when Medicare Part A days are exhausted.

Attachment F – Excel Bid Pages:

The following changes are hereby incorporated into the listing of drugs included on Excel Bid Pages – Attachment F. These changes are for informational purposes. Prospective bidders are not required to enter prices for items **not** currently listed on the Excel Bid Pages.

1. Generic drug Hydrocodone 5/500 mg tablet is no longer produced. This item will be ordered in 5/325 mg strength.
2. OTC Drug Cranberry Capsules will be ordered in 475 mg strength.

All other terms and conditions remain unchanged.
