### Main Purpose of Job

The Contractual Community Health Nurse I is the intermediate level of direct nursing care to patients in various community settings and local health department clinics. Employees in this class do not supervise other nursing staff but may supervise support staff. Employees receive moderate supervision from a Community Health Nurse Supervisor, other higher-level nurse or other designated higher level administrator. Employees may be subject to call-in and overtime based on staffing needs. The work may be performed at patients' homes, schools and other community settings where travel is required and the environment is often unpredictable. Employees are required to observe infection control precautions in order to prevent contamination and spreading disease. The work may require the lifting and positioning of non-ambulatory patients and the lifting of wheelchairs and other heavy equipment. The work may require long periods of standing, walking, bending and reaching. The Community Health Nurse I performs duties under close supervision at

times and under general supervision at other times depending on the complexity of the specific duty being performed.
