Your license to practice as either as a Speech-Language Pathologist or a Speech-Language Pathology Assistant, is under review due to non-compliance with the Continuing Education (CEU) audit sent to you in December of 2019, via the mailing address on record. If you have ASHA track your CEU courses, you may request a transcript for the 2018 and 2019 CEUs you have completed and send that transcript to Ms. Mouzone via email as indicated above.
