Please be advised that the State of Maryland Board of Chiropractic & Massage Therapy (the "Board") voted to summarily suspend your registration to practice massage therapy in the State of Maryland.

You have the opportunity to appear before the Board for a Show Cause Hearing. This limited appearance is intended to provide you with an opportunity to show cause why the Order should not be continued. At a Show Cause Hearing, you have the opportunity either through counsel or in person to address the Board representative(s). If you wish to appear before the Board for a Show Cause Hearing, you must notify the Board, in writing, **within 30 days** of your receipt of this Order. **ORDER FOR SUMMARY SUSPENSION**

Pursuant to Md. State Govt. II Code Ann. ("S.G. II") §10-226 (c) (2014 Repl. Vol.) and the Maryland Chiropractic Act (the "Act"), Md. Health Occ. Code Ann. ("H.O.") § 3-5A-01 *et seq.* (2014 Repl. Vol.) the Board of Chiropractic and Massage Therapy Examiners (the "Board") hereby summarily suspends the registration of **TIMOTHY SNYDER, RMP, REGISTRATION NUMBER: R02245, (the "Respondent")**, to practice as a registered massage practitioner under the Act. This Order is based on the following investigative findings, which the Board has reason to believe are true:<sup>1</sup>

**FINDINGS OF FACT**

1. The Respondent is a registered massage practitioner in the State of Maryland under Registration Number R02245. The Respondent was first registered on May 14, 2015. The Respondent's registration is current and is scheduled to expire on October 31, 2016.

2. On or about December 2, 2015, the Baltimore County Police Department, Vice Unit ("BCPD") notified the Board that the Respondent was arrested and charged with three counts of fourth degree sex offense and three counts of second degree

assault in connection with his employment at a spa ("the spa") in Baltimore, Maryland, where the Respondent was employed as a registered massage practitioner.

3. Thereafter the Board initiated an investigation.

4. In furtherance of its investigation, the Board's investigator obtained a copy of the Application for Statement of Charges, which contained the allegations against the Respondent.

5. The Application for Statement of Charges detailed three separate incidents in which massage clients at the spa where the Respondent was employed alleged that the Respondent touched them in an unprofessional and sexual manner, without their consent.

6. Client A, a female, alleged that on October 17, 2015, the Respondent massaged her pectoral muscles and her inner thighs and continuously touched/massaged the outside of her underwear in her crotch/vaginal area. Client A also alleged that the Respondent attempted to pull down her underwear and massaged her buttocks, continually running his hand between her buttocks.

7. Client B, a female, alleged that on November 17, 2015, while the Respondent massaged her inner thighs, the Respondent moved her underwear to the side, exposing her vagina. Client B alleged that she then felt the Respondent penetrate her vagina with his finger. Client B alleged that the Respondent attempted to pull down her underwear. Client B alleged that she felt what she believed to be the Respondent's erect penis pressing against her side.

8. Client C, a female, alleged that on November 18, 2015, the Respondent touched her vagina with his hand and ran his hand between her buttocks. Client C also



alleged that the Respondent ran his hand in the center of her vaginal area and into the folds of her vagina. Client C alleged that when she turned onto her back, the Respondent did not drape her properly and her vagina was fully exposed.

9. Client C notified the spa of the incident and the Respondent was terminated.<sup>2</sup>

10. As a result of the allegations against the Respondent by Clients A, B and C, the Respondent was charged in the District Court of Maryland for Baltimore County with three counts of assault, second degree and three counts of sex offense, fourth degree-sexual contact.

11. The criminal case against the Respondent is pending and a trial is scheduled for March 14, 2016.

#### CONCLUSIONS OF LAW

Accordingly, the Board concludes that the public health, safety or welfare imperatively requires emergency action in this case, pursuant to Md. State Gov't Code Ann. § 10-226(c)(2)(i) (2014 Repl. Vol.).

#### ORDER

Based on the foregoing, it is this 29 day of December 2015, by a majority vote of a quorum of the Board, hereby:

**ORDERED** that pursuant to the authority vested by Md. State Gov't II Code Ann., § 10-226(c)(2) Registration No. R00773, the Respondent's registration to practice as a registered massage practitioner in Maryland, is hereby **SUMMARILY SUSPENDED**; and be it further



**ORDERED** that the Respondent must request a post-deprivation show cause hearing in writing **WITHIN THIRTY (30) DAYS** of his receipt of this notice. The written request should be made to: Laurie Sheffield-James, Executive Director, Maryland Board of Chiropractic & Massage Therapy Examiners, 4201 Patterson Avenue, Baltimore, Maryland 21215 with copies mailed to: Tracee Orlove Fruman, Assistant Attorney General, Office of the Attorney General, 300 West Preston Street, Suite 207, Baltimore, Maryland 21201, and Grant Gerber, Assistant Attorney General, Office of the Attorney General, 300 West Preston Street, Suite 302, Baltimore, Maryland 21201; and be it further

**ORDERED** that if the Respondent fails to request a post-deprivation show cause hearing, the Respondent's registration will remain suspended; and it is further

**ORDERED** that the Respondent shall immediately turn over to the Board his registration to practice as a registered massage practitioner issued by the Board; and be it further

**ORDERED** that this document constitutes an Order of the Board and is therefore a public document for purposes of public disclosure, as required by Md. General Provisions Code Ann. §§ 4-101 *et seq.* (2014 Repl. Vol.).
