### **Potential Questions for Public Comment**

Background: The Consortium on Coordinated Community Supports was created by the Maryland General Assembly to develop an integrated, holistic plan for prevention, treatment, and recovery for Maryland students with behavioral health needs and other related challenges. The Consortium is developing recommendations for a program that will award grants to Community Supports Partnerships across the state. Community Supports Partnerships will engage a wide range of community stakeholders to provide behavioral health and wraparound services for Maryland students. Partnership grants will be issued and administered by the Maryland Community Health Resources Commission.

The Consortium's Data Subcommittee is seeking public comment on key questions to guide its recommendations for the program. The Consortium's Framework, Design & RFP Subcommittee will seek public comment on other topics related to the program.



### **Potential Questions for Public Comment**

- 1. What relevant baseline data is currently available to measure the impact of the Consortium and grant-funded Community Support Partnerships?
- 2. Which standardized process and outcome measures should all grantees be responsible to collect and report?
- 3. How could program impact be measured at the individual student level?
- 4. Which data sets or resources could the Consortium provide to help applicants develop their proposals?
