Appendix K (All waivers)	<p>This standalone appendix may be utilized by the state during emergency situations to request amendment to its approved waiver. It includes actions that states can take under the existing Section 1915(c) home and community-based waiver authority in order to respond to an emergency.</p> <p>All waivers have an approved Appendix K based on needs created during the COVID-19 pandemic.</p>	<p>Governor and Secretary's orders allowing operations outside of regulations will terminate on July 1, 2021; a 45-day period to unwind for certain flexibilities will end on August 15, 2021.</p> <p>Other flexibilities not affected and outlined in Appendix K can be effective no more than 6 months past the expiration of the public health emergency.</p>
