CONSENT AGREEMENT

Background

On August 31, 2002, Ms. Davies' license to practice pharmacy expired. Although Ms. Davies failed to submit a renewal application to the Board of Pharmacy (the "Board"), she continued to practice pharmacy until November 7, 2002, without a license. On November 12, 2002, the Board received a reinstatement application from Ms. Davies. The reinstatement application indicated that Ms. Davies completed 27.5 continuing education ("CE") hours during her 2000-2002 licensure period. The Board subsequently decided to enter into this Consent Agreement in lieu of filing formal charges against Ms. Davies for the unauthorized practice of pharmacy.

FINDINGS OF FACT

1. Ms. Davies was licensed to practice pharmacy by reciprocity on September 20, 2000. Ms. Davies' license expired on August 31, 2002.
2. In June 2002, the Board sent Ms. Davies a renewal application for the 2002 renewal term. Ms. Davies failed to return a completed renewal application to the Board.
3. Although her license expired on August 31, 2002, Ms. Davies continued to practice pharmacy without a license until November 7, 2002.
4. Ms. Davies submitted a reinstatement application to the Board on November 12, 2002. The reinstatement application evidenced that Ms. Davies completed 27.5 CE hours during the 2000-2002 licensure period. Ms. Davies was thus 2.5 credit hours short of the 30 CE hours required for renewal. Ms. Davies subsequently earned the additional 2.5 CE hours outside of the initial renewal period.

5. The Board reinstated Ms. Davies license on November 12, 2002, with the proviso that the Board may take action against her license for her violations of the Maryland Pharmacy Act.

CONCLUSIONS OF LAW

Ms. Davies engaged in the unauthorized practice of pharmacy from September 1, 2002, to November 7, 2002, in violation of Md. Code Ann., Health Occ. §12-701.

ORDER


Based on agreement of the parties, it is this 16th day of July 2003, by an affirmative vote of a quorum of the Board, hereby,

ORDERED that Ms. Davies shall complete 7.5 continuing education (CE) hours. Neither completion of the 7.5 CE's nor the 2.5 CE hours earned outside the renewal period will be credited toward Ms. Davies' 2004 renewal; and be it further,

ORDERED that Ms. Davies shall pay a fine of \$500.00; and be it further,

ORDERED that this is a final order of the Maryland Board of Pharmacy and as such is a public document pursuant to the Maryland Annotated Code, State Government Article, Section 10-617(h).
