ORDER LIFTING SUSPENSION

On July 16, 2011, Mr. Ojewoye submitted a petition to the Board of Pharmacy (the "Board") requesting that the Board lift the suspension of his license, License No. 13396, initially set forth in a Consent Order dated July 16, 2008. The Consent Order provides that Mr. Ojewoye may petition to lift the suspension after three (3) years, provided that he first enroll in and successfully complete a Board-approved ethics tutorial with a Board-approved supervisor. Mr. Ojewoye completed a Board-approved ethics tutorial and provided a transcript to the Board as proof of completion. On August 17, 2011, the Board voted to lift the suspension and place Mr. Ojewoye's license on immediate probation with terms as set forth below.

ORDER

It is this 14th day of Sept., 2011, by an affirmative vote of the Maryland Board of Pharmacy, hereby:

ORDERED that the suspension of Mr. Ojewoye's license be LIFTED; and be it further,

ORDERED that Mr. Ojewoye's license be placed on immediate PROBATION for at least THREE (3) YEARS, during which:

1. Mr. Ojewoye may not own a pharmacy or work for a pharmacy that is owned, in whole or in part, by a family member; and
2. Mr. Ojewoye shall ensure that his pharmacist supervisor submit quarterly performance reports to the Board; and be it further,

ORDERED that after one (1) year of probation, Mr. Ojewoye may petition the Board for modification of the probationary terms herein, provided that he has been fully compliant with the terms of probation and does not have any pending complaints filed against him; and be it further,

ORDERED that after three (3) years of probation, Mr. Ojewoye may petition the Board to terminate probation, provided that he has been fully compliant with the terms of probation and does not have any pending complaints filed against him; and be it further,

ORDERED that Mr. Ojewoye shall at all times cooperate with the Board in the monitoring, supervision, and investigation of Mr. Ojewoye's compliance with the terms and conditions of this Order; and be it further,

ORDERED that Mr. Ojewoye's failure to fully cooperate with the Board shall be deemed a violation of the probationary terms and a violation of this Order; and be it further,

ORDERED that in the event the Board finds in good faith that Mr. Ojewoye has violated any of the conditions of probation herein, or in the event the Board finds in good faith that Mr. Ojewoye has committed a violation of Title 12 of the Health Occupations Article or regulations adopted thereunder, the Board may take further disciplinary action against Mr. Ojewoye, provided that Mr. Ojewoye is given notice and an opportunity for a hearing; and be it further,

ORDERED that Mr. Ojewoye shall bear any expenses associated with the Order; and be it further,

ORDERED that this is a formal order of the Maryland Board of Pharmacy and as such is a public document pursuant to the Maryland Annotated Code, State Government Article, Section 10-617(h).
